TOWN OF PLYMOUTH ELECTION

Spring Election - April 1, 2025 (Town Chair & 2 Town Supervisor seats) Nomination papers can begin to be circulated December 1, 2024 and are due in the clerk's office January 7, 2025 by 5:00 pm.

Any Town of Plymouth resident wanting additional information should contact the Town Clerk.

All elections are held at the Town Hall. Polls are open from 7:00 am - 8:00 pm on Election Day.

BUILDING PERMIT INFORMATION

Permits are required for projects over \$2,000.
Additions, garages, remodeling, windows, siding, roofs and any other projects or alterations including plumbing, heating. **NOTE**: An Electrical Permit must

be taken out no matter the cost of the project. Building permits are valid for one (1) year.

PLEASE PLAN AHEAD...For garages, sheds, barns, other outbuilding or home additions do require Sheboygan County Planning approval first. This process may take some time. Make arrangements before you start construction to avoid delays and additional costs. Their number is 920-459-3060. They will let you know what they need. After receiving County approval, you can then apply for your building permit through the Town.

DRIVEWAY/CULVERT INFORMATION

Driveways and/or culverts require a permit.

LARGE BURN FIRES

2025 DATES TO REMEMBER

January 7, 2025 - Last day to file nomination papers (must be turned into the Clerk by 5 pm)
January 31, 2025 - Last day to pay 1st installment of Real Estate Taxes
February 18, 2025 - Spring Primary Election (if required)

March 31, 2025 - Dog License Deadline

April 1, 2025 - Spring Election

April 15, 2025 - Annual Town Meeting

May 2025 - Watch for Open Book & Board of Review Notices on the website and at the Town Hall July 31, 2025 - Last day to pay 2nd installment of Real Estate Taxes to Sheboygan County

TAX COLLECTION INFORMATION:

Full or 1st installment due by January 31st

There are different options (see below) to pay your Real Estate Property Taxes.

Include the upper portion of your tax bill with your check made payable to: TOWN OF PLYMOUTH.

If you have a check from your mortgage company and it is made out to you and the Town of Plymouth, remember to endorse it. If you are paying in cash, use the bank option.

If you'd like a receipt, enclose a self-addressed stamped envelope.

Payment options are as follows: Dropbox and Mailed payments are encouraged

In-Person: During regular office hours - Tuesday 8:00 am - 5:00 pm

Mail payments to: Town of Plymouth, 120 Suhrke Rd, Plymouth, WI 53073

<u>Dropbox:</u> Located to the left of the office door (available 24 hours a day, picked up Monday - Friday)

<u>Hiawatha National Bank</u> – 777 Walton Dr, Plymouth **Payments will be accepted in the lobby only.**Checks must be for the exact amount and you must have your tax bill with your payment.

<u>Friendly reminder:</u> 2nd installment Tax Payments must be paid to the Sheboygan County Treasurer by July 31st. Make check payable to: Sheboygan County Treasurer, mail your payment to Sheboygan County Treasurer, 508 New York Avenue, Sheboygan, WI 53081.

By State Statute: the Town Clerk/Treasurer cannot collect the 2nd installment payment.

DOG LICENSING INFORMATION

Neutered/Spayed dogs - \$7 Unaltered dogs - \$14 Late Fee - \$20 per dog

Late fees will be charged after April 1st

To obtain a license please submit a current rabies vaccination certificate (not an invoice), the appropriate fee (checks made payable to Town of Plymouth) and a self-addressed stamped envelope.

Payment options are as follows:

In-Person: During regular office hours - Tuesday 8:00 am - 5:00 pm

Mail payments to: Town of Plymouth, 120 Suhrke Rd, Plymouth, WI 53073

Dropbox: Located to the left of the office door (available 24 hours a day and picked up daily)

By State Statute: Any dog kept in the Town of Plymouth, over 5 months old, must be licensed by March 31st. An owner acquiring a new dog greater than 5 months of age must obtain a license within 30 days of taking ownership. If your dog has passed away or you no longer have him/her, please contact the clerk's office so the records can be updated. Thank you!

SNOW REMOVAL SEASON IS HERE!

DO NOT plow snow across the road or into the opposite ditch. Shoveling, blowing or plowing snow from driveways or parking lots into town roads (including pushing snow across the road) can cause serious traffic hazards. Plowing into the public roadway creates unnecessary hazards for motorists and pedestrians and causes increased time and effort into cleaning or re-plowing the roads. This is a safety issue and re-plowing is **NOT** a good use of tax dollars!
